Vendor Application
March 13-14, 2020**

Dear Vendor:

The Bandera Wranglers will present the BANDERA HAM RODEO on Friday, March 13th through Saturday, March 14th, 2020. Friday gates open at 4 pm and Saturday's gates will open at 8:00 am.

Vendor Set-up/Tear-Down: Vendor's will set-up Friday, March 13th and teardown Sunday, March 15th. Vendor Registration will be done prior to the event and vendors will receive a vendor packet via mail after the registration has been paid in full. Vendor packets will include passes to get in and out of the venue.

- Only individuals with a vendor pass will be allowed to enter the event area. Anyone who does not have a pass will be required to purchase one.
- Late vendors will not be permitted to set up after Saturday at 8:00 am. Any vendor who does not show and does not cancel will not receive a refund of fees.
- Booths must fit inside space purchased
- Booth locations will be assigned based on registration date

Vendor Booth Rates

- FOOD TENT: \$ (10x10) - Must be self-contained with electric, water, and gas
- FOOD TRUCK: \$ (10X20) - Must be self-contained with electric, water, and gas
- GOLD: \$100 (10x10) (\$1.00/sq. ft.) - Must provide own electricity
- SILVER: \$50 (10x10) (\$0.50/sq./ft.) - Must provide own electricity
- BRONZE: \$25 (10X10) (\$0.25/sq./ft.)- Must provide own electricity

Application/Contract Deadline

- A minimum of 50% the Booth Rate MUST be received *prior* to March 1, 2020
- Full Payment is required on March 1st
- Make Checks Payable to **Bandera Wranglers**

- Application required for all vendors
- Ham Rodeo Contract must be signed by ALL vendors

1. It is agreed that the Exhibitor will fill out, sign, and return this contract.
2. **It is agreed that booths will be rented for the entire show and that the Exhibitor for the duration of the show will tend booths. Vendors must open for business at 5:00 pm on Friday and will not close their booth before 10:00 pm. Saturday hours will be 8:00 am sharp and will not close their booth before 5:00 pm.** Vendors will be allowed to remain open for as long as they wish after 5:00 pm. It is further agreed that there will be no subleasing of booth space. ALL EXHIBITORS SHARING A BOOTH AND SELLING MERCHANDISE MUST SIGN CONTRACT.
3. It is agreed that any objects exhibited by the Exhibitor be his/her responsibility at all times, and Exhibitor shall be responsible for his/her safety and bear any loss by reason of theft, breakage, or other casualty.
4. It is agreed that Exhibitor will comply with any and all requirements of any government authority be it federal, state, or local – and to indemnify and hold harmless the promoters and the show facility owners, and all its constituents, from any and all liability due to failure to comply with any regulations.
5. It is agreed that the promoters reserve the right to make further rules and regulations, and such changes, regarding this event as they deem necessary and proper: and upon notice to Exhibitor all said action should become part of this contract and binding on the parties hereto.
6. It is agreed that the Exhibitor will release the promoters and the show facility owners and all its constituents from any and all liability for damages, injury or loss to any person or goods from any cause whatsoever, and further agrees to indemnify the promoters from any and all claims for damage, injury or loss.
7. It is agreed that violators of these rules may constitute non-participation in future rodeos.
8. IT IS AGREED THAT ALL VENDOR SPACE FEES ARE NON-REFUNDABLE.
9. IT IS AGREED THAT VENDOR SPACE FEES ARE PAYABLE UP FRONT; NO FEE'S WILL BE COLLECTED AT THE RALLY SITE.
10. Bandera Ham Rodeo has the exclusive right to display, license, sell and merchandise all event novelties (t- shirts, ride pins, etc.). Bandera Ham Rodeo further has the right to inspect, approve, reject or otherwise control the display, promotion, sale or other merchandising of products or services by exhibitors at the event in its sole discretion. Any products or services rejected by Bandera Ham Rodeo must be immediately removed from the event premises and may be removed by Bandera Ham Rodeo if this does not occur.

Merchandise designed to be passed off as event merchandise (use of Bandera, rodeo dates, event name, trademarks, etc.) or which has this effect will not be permitted. No signage may be displayed in Exhibitor space reading “Official Rodeo Merchandise”, “Rodeo Merchandise”, “Rodeo Tees”, “Event Tees” or any similar language advertising the sale of event merchandise. “BANDERA HAM RODEO” is a trademark of Bandera Wranglers. Any vendor found selling merchandise that infringes on these trademarks may be asked to leave immediately and will be subject to legal recourse.
